

DECISION
of Central Election Commission
of the Republic of Azerbaijan
on the rule of preparation of final voting results protocols of election
commissions in the Elections to the Milli Majlis of the Republic of Azerbaijan
appointed to November 1, 2015

Pursuant to Articles 100.1-100.6 of the Election Code of the Republic of Azerbaijan, the rule of preparation, text and format of the voting protocols, their number, requirements for their preparation shall be approved at latest 45 days prior to the voting day by decision of the Central Election Commission of the Republic of Azerbaijan (CEC) and the protocols shall be prepared in a relevant manner at latest 30 days prior to the voting day.

The format and text of final protocol samples of Constituency and Precinct Election Commissions on the voting results in regard with the Elections to the Milli Majlis have been defined by Comments approved by Decisions# 10/89 and 10/90 of the Central Election Commission of the Republic of Azerbaijan, dated May 25, 2015.

In this regard, protocols on the voting results of the relevant election commissions shall be printed at the Press of the Milli Majlis Apparatus of the Republic of Azerbaijan from 30 unnumbered and uncarbonized papers for Precinct Election Commissions, as well as for each of these bodies according to the number of the Constituency Election Commissions and precincts where the voting has been arranged in accordance with the number of the election constituencies and precincts where elections are to be conducted, these protocols shall be prepared in conformity with the format and text of the samples defined by the CEC by indicating their series and successively numbering them on constituencies, consisting of 3 copies, each copy being in the form of booklet from the carbonized papers in different colors.

Adopting the above-mentioned as a basis and pursuant to Articles 19.4, 19.14, 25.2.6, 25.2.11, 28.2, 28.4 and 100 of the Election Code of the Republic of Azerbaijan, CEC decides:

1. In regard with the Elections to the Milli Majlis appointed to November 1, 2015, protocols on the voting results of the relevant election commissions shall be prepared at the Press of the Milli Majlis Apparatus of the Republic of Azerbaijan in press manner from 30 unnumbered and carbonized papers for Precinct Election Commissions, as well as for each of these bodies according to the number of the Constituency Election Commissions and precincts where the voting has been arranged in accordance with the number of the election constituencies and precincts where elections are to be conducted, these protocols shall be prepared in conformity with the format and text of the samples defined by the CEC by indicating their series and successively numbering them on constituencies, consisting of 3 copies, each copy being in the form of booklet from the carbonized papers in different colors.

2. CEC Secretariat of the Republic of Azerbaijan and Press of the Milli Majlis Apparatus of the Republic of Azerbaijan shall undertake the implementation of the decision within their competences.

3. The decision shall be enforced upon its publication.
