

DECISION

of Central Election Commission of the Republic of Azerbaijan

on the registration of authorized representatives and authorized representatives on financial issues of the “AZADLIG-2015” bloc of political parties in the Elections to the Milli Majlis of the Republic of Azerbaijan on November 1, 2015
