

DECISION

of Central Election Commission of the Republic of Azerbaijan on consideration of the appeal # 13 submitted to the Central Election Commission on January 9, 2020 in the Elections to the MilliMajlis of the Republic of Azerbaijan on February 9, 2020

In his written apply addressed to the Central Election Commission on January 9, 2020, MammadovRasimAdil, self-nominee to deputy onZangilan – GubadlıCon.EC # 125in the Elections to the MilliMajlis of the Republic of Azerbaijan on February 9, 2020,challenged the decision # 18, dated January 6, 2020 the Con.EC on refusal to register his candidacy and requested for the redress of his violated rights upon making a relevant decision.

The complaint was adopted for the implementation in comply with Articles 112 and 112-1 of the Election Code of the Republic of Azerbaijan and “Instruction on the rules for submission and investigation of the appeals and complaints filed to the Central Election Commission of the Republic of Azerbaijan and Constituency Election Commissions”, relevant opinion was provided on this issue by a member of the Expert Group under CEC and considered at the Commission session upon the investigation of the appeal by the Expert Group member.

In the appeal nominee R.A.Mammadov informed that his candidacy had been nominated on own initiative on Zangilan – Gubadlı Con.EC # 125 in the Elections to the MilliMajlis of the Republic of Azerbaijan on February 9, 2020, signature sheets and other necessary documents attached to them were submitted to the Con.EC upon collecting voters’ signatures, but the Con.EC refused from registering his candidacy because he had not submitted correct information on the property belonging to him based on the right to property.

The applicant was contacted in connection with the investigation, was told to participate in the investigation and the session, and was told that he had other rights, and that his participation in the session was ensured.

The Con.EC substantiated its argued decision on the refusal from registering the candidacy of R.A.Mammadovon the grounds that he had not submitted correct information on the property belonging to him based on the right to property.

It was determined that candidate R.A.Mammadovdid not submit information about the real estate belonging to him to the Con.EC. In this regard, it is determined from the opinion of the Working Group under the Central Election Commission dated January 11, 2020 thataccording to a reference from the State Register Service of Real Estate under the State Committee on Property Issues, real estate belonging to candidate R.A.Mammadovhad been registered by state.

Thus, not providing correct information on property belonging to him by R.A.Mammadovto the Con.EC is the legal ground for refusal of registering the candidacy as in compliance with 60.2.3 of the Election Code.

Basing on the above-mentioned, the appeal shall not be implemented and the decision # 18 dated January 6, 2020 of that Con.EC on the refusal from registering the candidacy of R.A.Mammadov shall be remained in force without making amendments.

Taking the above mentioned as a basis, pursuant to Articles 19.4, 28.2, 59, 60, 112, 112-1 and 148 of Election Code of the Republic of Azerbaijan and item # 1,2,4,6 and 7 of the "Instruction on the rules for submission and investigation of the appeals and complaints filed to the Central Election Commission of the Republic of Azerbaijan and Constituency Election Commissions", the Central Election Commission decides:

1. The appeal # 13 submitted on January 9, 2020 by MammadovRasimAdil, self-nominee to deputy on Zangilan – Gubadlı Con.EC # 125in the Elections to the MilliMajlis of the Republic of Azerbaijan on February 9, 2020 shall not be implemented due to groundlessness and the decision # 18, dated January 6, 2020shall be remained in force without making amendments.

2. The decision shall be enforced upon its publication.
