DECISION

of Central Election Commission of the Republic of Azerbaijan

on the text, form, number and rule for the preparation of ballot papers in the Elections to the Milli Majlis of the Republic of Azerbaijan on November 1, 2015

Pursuant to Articles 99.1-99.4, 99.6, 166 of Election Code of the Republic of Azerbaijan demands on preparation, text and form, number of ballot papers shall be approved at latest 35 days prior to the voting day by decision of the Central Election Commission and prepared in relevant case under the observation of CEC representatives at least 10 days prior to the voting day providing that the number of the registered voters do not exceed 3 %.

Related with ballot papers to be used in the Elections to the Milli Majlis of the Republic of Azerbaijan on November 1, 2015 the above-mentioned rules and terms shall be taken as a basis, the upper left corners of these ballot papers which are cut and numbered one-by-one and successively on relevant constituencies shall be numbered, on the right of the information about candidates, an empty square, above the comment on the rules for filling, on the upper right corner place of stamp and on the below left corner cut line shall be located, the information indicating each registered candidate's surname, name, patronymic, date of birth, main place of working or service (if not any, then type of activity), name of the entities which nominated them, short name of the political party to which registered candidate nominated by political parties (blocs of political parties) belongs, text and form of requested party affiliation ballot paper of the registered candidate himself nominated on his/her own initiative or directly by voters initiative groups shall be approved, not to exceed 3 % of the number of total registered voters on the country, shall be prepared at the press of the Apparatus of the Milli Majlis of the Republic of Azerbaijan under the observation of 3 members of CEC based on CEC representation.

Taking the above-mentioned as basis, pursuant to Articles 19.4, 19.14, 25.2.6, 25.2.11, 28.2, 28.4, 99 and 166 of Election Code of the Republic of Azerbaijan, CEC **decides**:

- 1. The form and text of ballot papers, of having empty squares on the right to the information of the candidates, on the upper side having comment on its completion, on the upper right corner having place of stamp, on down left corner having cut line, as well as, indicating each registered candidate's surname, name, patronymic, date of birth, main place of working or service (if not any, then type of activity), name of the entities which nominated them, short name of the political party to which registered candidate nominated by political parties (blocs of political parties) belongs, party affiliation on the request of the registered candidate himself nominated on his/her own initiative or directly by voters initiative groups related to the Elections to the Milli Majlis of the Republic of Azerbaijan on November 1, 2015.
 - 2. In total, 5 344 431 (five million, three hundred and forty-four thousand four hundred and thirty-one) ballot papers shall be prepared at the press of the

- Apparatus of the Milli Majlis of the Republic of Azerbaijan under the observation of 3 members of CEC based on CEC representation.
- 3. CEC Secretariat and Press of the Milli Majlis Apparatus of the Republic of Azerbaijan shall be in their competence commissioned with the execution of the decision.
- 4. The decision shall be enforced upon its publication.
