of ID documents used on the voting day in elections (referendum)

List of identification documents used on the voting day in elections (referendum) of the Republic of Azerbaijan shall be defined by the Election Code of the Republic of Azerbaijan, Law of the Republic of Azerbaijan "On ID card of a citizen of the Republic of Azerbaijan", the List¹ and other legislative acts.

1. Identification documents used on the voting day within the Republic of Azerbaijan

- 1.1. The following documents shall be used within the Republic of Azerbaijan on the voting day:
- 1.1.1. ID card of the citizen of the Republic of Azerbaijan;
- 1.1.2. Temporary ID card of the citizen of the Republic of Azerbaijan.
- 1.2. Refugees and IDPs:
- 1.2.1. If there is not ID document implied by the item # 1.1 of the List, then a card in the form defined by the State Committee on IDP issues of the Republic of Azerbaijan.
- 1.3. For military servants being on real or temporary military service:
- 1.3.1. Personal card of an officer;
- 1.3.2. Military ID.
- 1.4. The prisoner condemned to punishment in detention places and special institutions:
- 1.4.1. ID document of the prisoner submitted by the Main Office on the control upon the realization of Court Decisions of the Ministry of Justice of the Republic of Azerbaijan
- 1.5. Persons serving punishment at the institutions of confinement (jails):
- 1.5.1. ID document of the accused citizen submitted by the Main Office on the control upon the realization of Court Decisions of the Ministry of Justice of the Republic of Azerbaijan.

¹During the election process, besides the above-mentioned documents, the usage of other documents shall be prohibited.

2. ID documents used outside of the Republic of Azerbaijan on the voting day

- 2.1. The following documents shall be used outside of the Republic of Azerbaijan on the voting day:
- 2.1.1. citizen passport;
- 2.1.2. service passport;
- 2.1.3. diplomatic passport.

3. Identification documents used by stateless persons and foreigners on the voting day within the Republic of Azerbaijan

- 3.1. for stateless persons permanently living for at least 5 years within the Republic of Azerbaijan;
- 3.1.1. Permission card²;
- 3.1.2. ID card³;
- 3.2. For foreigners living for at least 5 years within the municipality:
- 3.2.1. permission card.

4. Final provision

3.3. Since the enforcement of the List, the "List of ID documents used on the voting day in Presidential elections in the Republic of Azerbaijan" approved by CEC Decision # 9/39-2 dated 7 August 2008, the "List of ID documents used on the voting day in Referendum in the Republic of Azerbaijan" approved by CEC Decision # 1/4-7 dated 8 January 2009, the "List of ID documents used on the voting day in elections to the Milli Majlis in the Republic of Azerbaijan" approved by CEC Decision #10/49-1 dated 6 May 2010, the "List of ID documents used on the voting day in Municipal elections in the Republic of Azerbaijan" approved by CEC Decision # 6/15-9 dated 23 August 2011 shall be invalidated.

² A document which approves their identity and registration on residence within the country, provided by State Migration Service of the Republic of Azerbaijan in comply with Migration Code of the Republic of Azerbaijan.

³ A document provided to a stateless person aged above 16 in comply with "Regulation on specific documents of the stateless persons permanently living within the Republic of Azerbaijan".
