

DECISION

of Central Election Commission of the Republic of Azerbaijan
on the consideration of the appeal # 40 submitted to the Central Election Commission
on January 29, 2020 in the Elections to the MilliMajlis of the Republic of Azerbaijan,
appointed to February 9, 2020

Regarding the Elections to the MilliMajlis of the Republic of Azerbaijan, appointed to February 9, 2020, HikmatSattarAghayev, registered candidate on Lerik Con.EC # 78 and others applied to the Central Election Commission of the Republic of Azerbaijan (CEC) on January 29, 2020, claiming on the law violations during the conduct of pre-election campaign and requested to undertake relevant measures.

The complaint was adopted for the implementation in comply with Articles 112 and 112-1 of the Election Code of the Republic of Azerbaijan and "Instruction on the rules for filing appeals and complaints to the Central Election Commission and Constituency Election Commissions of the Republic of Azerbaijan and their consideration", relevant opinion was provided on this issue by a member of the Expert Group under CEC and considered at the Commission session.

H.S.Aghayev and others claimed in their appeal that he joined the Elections to the MilliMajlis of the Republic of Azerbaijan, appointed to February 9, 2020 as a candidate on Lerik Con.EC # 78 and from the day that campaign process started on January 17, 2020 as in comply with legislation, JalilYuzbashiBakhsiyev, agent of registered candidate IgbalNarimanMammadov had violated the requirements of Article 69 of the Election Code by sitting in the building of Lerik region executive authority, therewith, representatives of region executive authority, municipalities and members of polling stations arranged meetings of I.N.Mammadov.

The applicants were contacted in connection with the investigation, was informed on his rights to participate in the investigation and the session, the participation of plaintiff R.G.Husyenov at the Commission session was ensured.

It was determined through full and inclusive investigation that J.Y.Bakhshiyev was registered as an authorized representative of the New Azerbaijan Party in the Elections to the MilliMajlis of the Republic of Azerbaijan, appointed to February 9, 2020 and was set free from implementing his service activity during the period of participating in the election campaign as in compliance with Article 69.2 of the Election Code (the case is verified by the relevant Order).

The claims on the arrangement of meetings of I.N.Mammadov with voters in pre-election campaign by representatives of region executive authority, municipalities and members of polling stations were not justified in the reports provided by those actors and other persons.

Thus, it was determined as a result of investigation that since the claims of registered candidate H.S.Aghayev and others on the violation of the rules for conducting pre-election campaign had not been justified, legal grounds have not been established to implement the complaint.

Pursuant to 19.4, 28.2, 112 and 112-1 of Election Code of the Republic of Azerbaijan and item # 1, 2, 4, 6 and 7 of the "Instruction on the rules for filing appeals and complaints to the Central Election Commission and Constituency Election Commissions

of the Republic of Azerbaijan and their consideration" the Central Election Commission **decides:**

1. The appeal # 40 submitted to CEC on January 29, 2020 by HikmatSattarAghayev, registered candidate on Lerik Con.EC # 78 and others in the Elections to the MilliMajlis of the Republic of Azerbaijan, appointed to February 9, 2020 shall not be implemented due to groundlessness.
2. The decision shall be enforced upon its publication
