

**DECISION**  
**of Central Election Commission**  
**of the Republic of Azerbaijan**

**on the registration of the following persons as authorized representatives and authorized representatives on financial issues of the Modern Musavat Party in Presidential Elections of the Republic of Azerbaijan appointed on October 9, 2013**

In Presidential Elections of the Republic of Azerbaijan appointed on October 9, 2013, Modern Musavat Party which nominated candidate to presidency, appointed authorized representatives and authorized representatives on financial issues by Decisions 1/2 and 1/3 of session of the Modern Musavat Party dated on August 11, 2013 and submitted relevant documents to the Central Election Commission for the registration of these persons.
