## **RULES**

### **on providence with signature sheets for the collection of signatures to establish referendum campaign groups**

Providing the authorized representative of the referendum initiative group with signature sheets by the relevant election commission in order to collect signatures to establish referendum campaign groups shall commence since the day of getting information on receiving the notification by the commission sent to the relevant election commission by the initiative group.

While providing the authorized representative, the upper right corner of each signature sheet shall be sealed by the stamp of the secretariat of the relevant election commission.

Signature sheets shall be prepared in the form defined by Appendix 4 made to the Election Code of the Republic of Azerbaijan (hereafter referred to as Election Code) (Appendix # 2 made to the Rules).

When providing the authorized representative with signature sheets, an act consisting of two copies shall be compiled (Appendixes # 1 and 1a made to the Rules). The compiled act shall be approved by the seal of the secretariat of the commission after being signed by the authorized representative and authorized person of the relevant election commission.

After the compiled act being signed and sealed, one copy shall be preserved at the secretariat of the relevant election commission, another one shall be submitted to the authorized representative together with the signature sheets.
