

## **DECISION**

### **of Central Election Commission of the Republic of Azerbaijan**

**on consideration of the appeal # 41 submitted to the Central Election Commission on October 6, 2015 in the Elections to the Milli Majlis of the Republic of Azerbaijan on November 1, 2015**

In his written apply addressed to the Central Election Commission on October 6, 2015, Talibov Mikayil Abulfat, nominated on own initiative on Astara Con.EC # 77 challenged the decision of the Con.EC on refusal to register his candidacy and requested for the redress of his violated rights upon making a relevant decision.

The complaint was adopted for the implementation in comply with Articles 112 and 112-1 of the Election Code of the Republic of Azerbaijan and “Instruction on the rules for submission and investigation of the appeals and complaints filed to the Central Election Commission of the Republic of Azerbaijan and Constituency Election Commissions”, relevant opinion was provided on this issue by a member of the Expert Group under CEC and considered at the Commission session upon the investigation of the appeal by the Expert Group member.

In the appeal nominee M.A.Talibov informed that his candidacy had been nominated on own initiative on Astara Con.EC # 77 in the Elections to the Milli Majlis of the Republic of Azerbaijan on November 1, 2015, signature sheets and other necessary documents attached to them were submitted to the Con.EC upon collecting voters’ signatures within that constituency, but the Con.EC refused from registering his candidacy without any grounds.

The Con.EC substantiated its decision on the refusal from registering nominee M.A.Talibov on the grounds that the number of valid voters’ signatures to register the candidate had not been sufficient.

The protocol and opinions dated October 7, 2015, compiled by the Working Group under the Central Election Commission upon the examination of the necessary documents for the registration of the candidate reveal that the voters’ signatures included in signature sheets submitted for the registration of M.A.Talibov had been collected in comply with the rules enshrined in the Election Code. Thus, 469 of voters’ signatures collected by the candidate were considered valid, which is sufficient to register him.

Pursuant to Article # 147.1 of Election Code of the Republic of Azerbaijan, at least 450 voters’ signatures shall be collected in support of the candidate within the constituency the candidate has been nominated on.

Basing on the above-mentioned, the complaint shall be implemented due to grounded factors and the decision # 18/65 of Astara Con.EC # 77, dated October 3, 2015 on the

refusal from registering the candidacy of M.A.Talibov shall be annulled and he shall be registered as a candidate.

Taking the above mentioned as a basis, pursuant to Articles 19.4, 28.2, 28.4, 59, 60, 112, 112-1, 147.1 and 148 of Election Code of the Republic of Azerbaijan and item # 1, 2, 4, 6 and 7 of the “Instruction on the rules for submission and investigation of the appeals and complaints filed to the Central Election Commission of the Republic of Azerbaijan and Constituency Election Commissions”, the Central Election Commission decides:

1. The appeal # 41 submitted by Talibov Mikayil Abulfat, nominated on his own initiative on Astara Con.EC # 77 on October 6, 2015 in the Elections to the Milli Majlis of the Republic of Azerbaijan on November 1, 2015 shall be implemented due to grounded factors and the decision # 18/65 of that Con.EC dated October 3, 2015 shall be annulled.
2. Talibov Mikayil Abulfat, nominated on his own initiative on Astara Con.EC # 77 shall be registered as a candidate on that election constituency.
3. The decision shall be enforced upon its publication.
