

DECISION

of the Central Election Commission of the Republic of Azerbaijan on making amendments to “ Instruction on the rules for distribution of the allowances by the state budget among election commissions to prepare and conduct Elections to the Milli Majlis of the Republic of Azerbaijan and for the control on using of the funding on destination”

A number of legal acts adopted by the Central Election Commission (CEC) regarding the application of the Election Code of the Republic of Azerbaijan and preparation and conduct of elections (referendum) need to be improved due to the necessity of periodical development of the legislation of the Republic of Azerbaijan and further regulating the election (referendum) relations. “ Instruction on the rules for distribution of the allowances by the state budget among election commissions to prepare and conduct Elections to the Milli Majlis of the Republic of Azerbaijan and for the control on using of the funding on destination”, adopted by CEC shall be made relevant amendments in comply with Article 30 of the Constitutional Law of the Republic of Azerbaijan dated December 21, 2010.

Meanwhile, CEC shall ensure within its competence the implementation of the activities implied in legislation regarding the official publication and enforcement of the amendments.

Assuming the above-mentioned as a basis, the Central Election Commission of the Republic of Azerbaijan **decides** according to the Articles 75.2, 78.2 and 78.3 of the Constitutional Law of the Republic of Azerbaijan “On normative legal acts” and Articles 19.4, 19.14, 28.2, 28.4 of the Election Code of the Republic of Azerbaijan:

1. “Instruction on the rules for distribution of the allowances by the state budget to prepare and conduct Elections to the Milli Majlis of the Republic of Azerbaijan and for the control on using of the funding on destination”, approved by the decision # 15/52 of the Central Election Commission of the Republic of Azerbaijan, dated July 8, 2010:

1.1. The following preamble shall be added:

“The rules for distribution of the allowances by the state budget among election commissions to prepare and conduct Elections to the Milli Majlis of the Republic of Azerbaijan and for the control on using of the funding on destination shall be regulated by Articles 89, 96 and 97 of the Election Code of the Republic of Azerbaijan (hereinafter referred to as – Election Code), the Law of the Republic of Azerbaijan “On the budgeting system” and the Instruction”.

1.2. The words “1. Distribution of the allowances among election commissions” preceding the preamble, “2. Accounting of allowances, compile, submission and publication of financial reports (information)” preceding the item # 1.7 shall be added and the items and semi-items in the Instruction shall be appropriately numbered.

1.3. The words “of the Republic of Azerbaijan” and “(hereafter referred to as – Election Code)” preceding the item # 1.3 shall be excluded.

1.4. The words “I-62 dated July 15, 1998” in the item # 2.3 shall be replaced by the words “I-51 dated May 30, 2006”.

2. Within its competence, CEC shall ensure taking relevant activities implied by legislation for the official publication and enforcement of the Decision.
