

DECISION

of Central Election Commission of the Republic of Azerbaijan on consideration of the appeal # 56 submitted to the Central Election Commission on September 5, 2024 in the Elections to the Milli Majlis on September 1, 2024

Regarding the Elections to the Milli Majlis on September 1, 2024, Zakir Agaeli Ismayil, registered candidate from Musavat Party on Ujar Con.EC # 94 applied to the Central Election Commission of the Republic of Azerbaijan (CEC) on September 5, 2024, stated that the copy of the protocol of the constituency election commission was not given to him and requested to cancel the results of the voting for that electoral district.

The appeal was adopted for the implementation in comply with Articles 112 and 112-1 of the Election Code of the Republic of Azerbaijan (Election Code) relevant opinion was provided on filing the appeal upon violating the rules for destination by a member of the Expert Group under CEC and considered at the Commission session.

While reviewing the received application, it was determined that on voting day complaint part related to the alleged violations in the polling stations was given by transferring the period stipulated in the legislation and for this reason a member of the expert group gave an opinion on the return of the application in that part.

According to Article 112.1 of the Election Code, election subjects of citizens from decisions and actions (inaction) that violate their rights, that decision was published and or from the date of receipt, action (inaction) or about the interested person can file a complaint within 3 days from the day of receiving the information.

According to Article 112-1.14.1 of the Election Code, the complaint is determined by law in the prescribed order and period, i.e. from the decision, the action (inaction) within 3 days after issuing or notifying the interested party.

Application in the section where the protocol of the constituency election commission is investigated and determined that the constituency election commission that was allegedly not given a copy of the protocol was attached to the complaint by the candidate. Also according to the reference submitted by the constituency election commission Ujar No. 94, the certified copy of the protocol was sent by post to the address of the candidate Z.A. Ismayil.

Thus, giving a copy of the protocol to the candidate is provided by constituency election commission, the appeal should not be considered groundless in that part.

Pursuant to 19.4,19.14, 28.2, 112, 112-1 of Election Code of the Republic of Azerbaijan the Central Election Commission decides:

1.The appeal # 56 submitted to CEC on September 5, 2024 by Zakir Agaeli Ismayil, registered candidate from Musavat Party on Ujar Con.EC # 94 in the Elections to the Milli Majlis on September 1, 2024 shall be sent back to the applicant as the period of appeal established by the legislation in the part related to violations was given by

transmission and as the request that the copy of the protocol was not given to him was provided it shall be considered groundless.

2. The decision shall be enforced upon its publication.
