

## DECISION

of Central Election Commission of the Republic of Azerbaijan  
on the establishment of Expert Group under Central Election Commission  
to investigate the complaints against the actions (inactions) and decisions violating  
citizens' election rights in the Early Elections to the Milli Majlis of the Republic of  
Azerbaijan, appointed to 1 September, 2024

By the Order dated June 28, 2024 by President of the Republic of Azerbaijan, the Early Elections to the Milli Majlis of the Republic of Azerbaijan have been appointed to September 1, 2024.

Pursuant to Article 112-1.1 of Election Code of the Republic of Azerbaijan, Expert Groups shall be established consisting of 9 persons under the Central Election Commission (CEC) and 3 persons under the Constituency Election Commissions (Con.ECs) for investigating the complaints against the actions (inactions) and decisions violating citizens' suffrage.

In the aim of ensuring the efficiency of investigating complaints and appeals entered the election commissions in regard with the early Elections to the Milli Majlis of the Republic of Azerbaijan, relevant Expert Groups shall be established under the CEC and Con.ECs as implied in the Election Code.

According to the Articles 19.4, 19.14, 28.2, 28.4, 112 and 112-1.1 of Election Code of the Republic of Azerbaijan CEC decides:

1. In the aim of investigating the complaints against the actions (inactions) and decisions violating citizens' suffrage, Expert Group under CEC shall be established in the following composition during the Early Elections to the Milli Majlis of the Republic of Azerbaijan, appointed to 1 September 2024:

Ramiz Ibrahimov - Member of Central Election Commission of the Republic of Azerbaijan;

Fuad Javadov - Member of Central Election Commission of the Republic of Azerbaijan;

Gabil Orujov - Member of Central Election Commission of the Republic of Azerbaijan;

Bakhsheyish Asgarov - Member of Central Election Commission of the Republic of Azerbaijan;

Tofiq Hasanov- Member of Central Election Commission of the Republic of Azerbaijan;

Ilkin Shahbazov - Member of Central Election Commission of the Republic of Azerbaijan;

Naila Asgarova- Member of Central Election Commission of the Republic of Azerbaijan;

Ilgar Alizadeh - Head of Secretariat of Central Election Commission of the Republic of Azerbaijan;

Rafiq Abbasov - Head of Law Department of CEC Secretariat of the Republic of Azerbaijan;

2. The establishment of Expert Group of 3 persons under the Con.ECs shall be undertaken by Con.ECs.
3. The decision shall be enforced upon its publication.
