

DECISION

of the Central Election Commission of the Republic of Azerbaijan
on the registration of the agents of registered candidate Mr. Fuad Aghasi oghlu Aliyev
in the early Presidential elections of the Republic of Azerbaijan,
appointed to February 7, 2024

In the early Presidential elections of the Republic of Azerbaijan appointed to February 7, 2024, Mr. Fuad Aghasi oghlu Aliyev, registered candidate to the Presidency of the Republic of Azerbaijan appointed agents and submitted relevant documents to the Central Election Commission (hereafter referred to as - CEC) for the registration of these persons.
