

## DECISION

of Central Election Commission of the Republic of Azerbaijan on the registration of authorized representatives and authorized representatives on financial issues of the Motherland Party in the Elections to the Milli Majlis of the Republic of Azerbaijan on February 9, 2020

The Motherland Party has appointed authorized representatives and authorized representative on financial issues by the Decision of the Supreme Assembly, dated 7 December, 2019 and submitted the relevant documents for the registration of those persons to the Central Election Commission regarding the Elections to the Milli Majlis of the Republic of Azerbaijan on February 9, 2020.
