## DECISION

of Central Election Commission of the Republic of Azerbaijan on the text, format, numberand rule for the preparation of ballot papers in the Elections to the MilliMajlis of the Republic of Azerbaijan, appointed to February 9, 2020

Pursuant to Articles 99.1-99.4, 99.6, 166 of the Election Code of the Republic of Azerbaijan (Election Code), the rules for preparation, text andformat, number of ballot papers shall be approved at latest 35days prior to the voting day by decision of the Central Election Commission (CEC) and prepared inrelevant manner under the observation of CEC representatives at least 10 days prior to the votingday providing that the number of the registered voters do not exceed 3%.

Regarding the Elections to the MilliMajlison February 9, 2020, the above-mentioned rules and terms on the ballot paperto be used shall be taken as a basis and approved, the upper left corner of which has been cut successively on the existingelection constituencies, also containing an empty square on the right of the candidates' information andComment on the rules for completing above, place of stamp on upper right corner and cutline on lower right corner, as well as, indicating candidates' surnames, names, patronymics inalphabetic order, dates of birth, addresses of residence, main place of work or service (in theirabsence type of occupation), name of the nominating body, short name of the political party, political party bloc which have nominated them and party affiliation on own request of a candidatenominated on their own initiative or directly by voters, and the ballot papers shall be printed at thePress of the MilliMajlis Apparatus under the observation of 3 CEC members in comply withrepresentation norm providing that the total number of ballot papers would not exceed 3 % ofvoters' number registered on the country.

Assuming the above-mentioned as a basis and pursuant to Articles 19.4, 19.14, 25.2.6, 25.2.11,28.2, 28.4, 99 and 166 of the Election Code of the Republic of Azerbaijan and the item # 2.1 of the above-mentioned Rules, CEC **decides**:

- 1. Regarding the Elections to the MilliMajlison February 9, 2020, the text and format of the ballotpaper shall be approved the upper left corner of which has been cut successively on the existingmunicipalities, also containing an empty square on the right of the candidates' information andComment on the rules for completing in the above, place of stamp on upper right corner and cutline on lower right corner, as well as, indicating candidates' surnames, names, patronymics inalphabetic order, dates of birth, addresses of residence, main place of work or service (in theirabsence type of occupation), name of the nominating body, short name of the political party,political party bloc which have nominated them and party affiliation on own request of a candidatenominated on their own initiative or directly by voters.
- 2. Upon defining the number of ballot papers as 5 387 600 (five million three hundred and eighty seven thousand six hundred), the ballot papersshall be printed at the Press of the MilliMajlis Apparatus under the observation of 3 CECmembers.

- 3. CECSecretariat and Press of the MilliMajlis Apparatus of the Republic of Azerbaijan shallundertake the implementation of the decision within their competence.
- 4. The decision shall be enforced upon its publication.
