

**RULES**  
**for submitting information on the amount and source**  
**of income and property of the candidate in elections**  
**of the Republic of Azerbaijan**

The information on the amount and source of income and property of the candidate during elections of the Republic of Azerbaijan shall be submitted in accordance with Articles 58.1, 58.1.4, 58.1.5 and 58.3 of Election Code of the Republic of Azerbaijan (hereafter referred to as - Election Code) and the Rules.

**1. General provisions**

1.1. The candidate or his/her authorized representative, authorized representatives of political parties, blocs of political parties shall submit information on the amount, source of income and the property which belongs to the candidate basing on the right to property together with necessary documents to Central Election Commission of the Republic of Azerbaijan to be registered for candidacy (hereafter referred to as - CEC) (Appendix # 5 to Election Code and Appendices # 1 and # 2 to Rules).

1.2. This information shall cover a year since the day of official publication of the decision (order) on the appointment of elections. Meanwhile, this information shall be attached references on the total amount of this income provided by the organizations and individuals which provided the income.

**2. Definition of the concepts included in the Rules**

2.1. **Salary from the main place of work** means payments for the fulfill of the works on certain profession, degree and position by citizens in terms of labor contracts signed with legal entities (enterprises, offices, organizations, etc.) despite the type of property, or for the fulfill of labor functions by actors of entrepreneurship activity (individual entrepreneur, farm economy, corporation and so on) at public or religious organizations, activity of lawyer, service or education.

2.2. **Reward and financial aid** shall be understood as reward for the result of the work, reward for the service term, all types of the supplementary rewards related to the anniversary, holiday, birthdays and stimulating payments in other similar cases, other rewards for the fulfilling labor functions and all types of financial support.

2.3. **Income from the civic-legal contracts** shall be understood as incomes achieved from amnesty, substitution and fulfilling the works out of the duty

(on one occasion and substitution).

2.4. **Incomes from the ownership activity** shall be understood as incomes from types of activity implied by the current legislation of the Republic of Azerbaijan and not prohibited by law (the income indicated in the report submitted to the tax bodies for the final year by the physical person who is engaged in ownership).

2.5. **Income not from the ownership activity** means the following incomes excluding the profit from waged labor or activity of ownership:

- 2.5.1. percentages received from banks and credit organizations;
- 2.5.2. dividends;
- 2.5.3. copyright;
- 2.5.4. royalty;
- 2.5.5. income from transactions on securities;
- 2.5.6. amount of the remitted debt;
- 2.5.7. income from the property rent;
- 2.5.8. income on life insurance;
- 2.5.9. presents and financial aid from the persons who is not a member of the family;
- 2.5.10. heritage;
- 2.5.11. lottery prizes;
- 2.5.12. joint incomes (property and other income during the marriage period of the couples, joint property and so on);
- 2.5.13. other incomes not prohibited by law.

2.6. The property information shall be approved by the references submitted by the relevant organizations conducting the registration of the property right.

### **3. Final provisions**

3.1. Since the enforcement of the Rules, "Rules for submitting the information on the amount, sources of income and property of the candidate to municipality membership", approved by CEC decision # 16/99 dated August 28, 2004, "Rules for submitting the information on the amount, sources of income and property of the candidate to deputy in Elections to the Milli Majlis of the Republic of Azerbaijan", approved by CEC decision # 13/43 dated July 4, 2005 and "Rules for submitting the information on the amount, sources of income and property of the candidate to residency of the Republic of Azerbaijan", approved by CEC decision # 6/42 dated June 18, 2013 shall be invalidated.
