

## DECISION

### **of the Central Election Commission of the Republic of Azerbaijan on the consideration of the appeals # 56 and 58, dated December 26, 2014 and #79, dated December 28, 2014, received by the Central Election Commission regarding the Municipal Elections held on December 23, 2014**

Nariman Yusif Narimanov, registered candidate on Sarijali municipality of Aghjabedi-Fuzuli Con.EC # 83 appealed to CEC regarding the Municipal elections on December 23, 2014, complained that the final protocol on the voting results had been compiled at the Con.EC not at the PEC after the vote calculation and requested to undertake relevant measures.

Registered candidates on that municipality - Huseynov Mushvig Firuddin, Gasimov Rashad Həbib, Huseynova Shafiga Farhad also appealed to CEC with the appeals on the same theme.

The complaints were adopted for the implementation in comply with Articles 112 and 112-1 of the Election Code of the Republic of Azerbaijan and "Instruction on the rules for filing appeals and complaints to the Central Election Commission and Constituency Election Commissions of the Republic of Azerbaijan and their consideration", relevant opinion was provided on this issue by a member of the Expert Group under CEC and considered at the Commission session upon the investigation of the appeals by the Expert Group member.

Basing on the explanations and compiled acts by the members of Aghjabedi-Fuzuli Con.EC # 83 and PEC # 26 of that election constituency, other registered candidates on Sarijali municipality and observers who had observed in that polling station during the investigation, the claim on compiling the final protocol on the voting results at the Con.EC not at the PEC has not been justified.

So, Z.Kh.Sadigova, secretary of the PEC # 26, expressed in his explanation that final protocol on the voting results had been compiled by him, signed by the commission members, one copy was hanged on the information board and copies were delivered to observers and registered candidates.

Furthermore, A.M.Suleymanov, M.H.Adilov, registered candidates on Sarijali municipality, F.A.Dadashov, G.A.Huseynov observers who had observed in polling station # 26 expressed in their explanations that there was not any law violation in the voting process, final protocol on vote calculation and voting results was compiled at the Con.EC as defined by alw.

As through full, detailed, fair and impartial investigation of the appeal and written evidences, the cases claimed in the appeal had not been justified, the complaint shall not be implemented.

By assuming the above-mentioned as a basis and pursuant to Articles 19.4, 28.2, 112, 112-1 of the Election Code of the Republic of Azerbaijan and items # 1, 2, 4, 6, 7 of "Instruction on the rules for filing appeals and complaints to the Central Election Commission and Constituency Election Commissions of the Republic of Azerbaijan and their consideration", CEC **decides:**

1. The appeal # 56 dated December 26, 2014 by registered candidates on Sarijali municipality Aghjabedi-Fuzuli Con.EC # 83 - Nariman Yusif Narimanov, appeal # 58 dated December 26, 2014 by Huseynov Mushvig Firuddin and Gasimov Rashad Habib and appeal # 79, dated December 28, 2014 by Huseynova Shafiga Farhad shall not be implemented due to their groundless factors.
2. The decision shall be enforced upon its publication.
