

DECISION
of Central Election Commission
of the Republic of Azerbaijan

on the registration of the following persons as authorized representatives and authorized representatives on financial issues of the Citizen and Development Party in Presidential Elections of the Republic of Azerbaijan appointed on October 9, 2013
