RULES

for providing the candidate to deputy, their authorized representatives, authorized representatives of political parties, political party blocs with signature sheets by the Constituency Election Commission in Elections to Milli Majlis in the Republic of Azerbaijan

The rules for providing the candidate for deputy, their authorized representatives and the authorized representatives of political parties, political party blocs with signature sheets by Constituency Election Commissions for collecting signatures during Elections to the Milli Majlis of the Republic of Azerbaijan shall be regulated by the Election Code of the Republic of Azerbaijan and the Rules.

1. Requirements for providing with signature sheets

- 1.1. Providing the candidate to deputy, their authorized representatives, the authorized representative of political parties and blocs of political parties with signature sheets by the Constituency Election Commission (Con.EC) to collect signatures in support of the candidate shall commence sine the day of adopting the decision that approves the candidate nomination.
- 1.2. While providing the candidate, his/her authorized representative, authorized representatives of political parties and blocs of political parties with signature sheets, the upper right corner of each signature sheet shall be sealed by the stamp of the Con.EC. The candidate or the authorized representative who received signature sheets shall sign on the bottom corner of each signature sheet.
- 1.3. Signature sheets shall be prepared in the form defined by Appendices 1 and 1 "A" made to the Election Code of the Republic of Azerbaijan (Appendices #2 and 2a made to Rules).
- 1.4. When providing the candidate or the authorized representative with signature sheets, an act consisting of two copies shall be compiled (Appendix # 1 made to the Rules). After being signed by the Con.EC Chairman, candidate or the authorized representative, the compiled act shall be approved by the stamp of the Con.EC.
- 1.5. The act on the reception of signature sheets shall contain the surname, name, patronymic of the candidate or the authorized representative, the form and number of the submitted signature sheets and other information shall also be indicated.
- 1.6. After the compiled act is signed and sealed, a copy of it shall be preserved at the Con.EC, another copy shall be submitted to the candidate or the authorized representative together with signature sheets.
